#### Source(s) of Drinking Water

Type(s) of water: Groundwater from the Carrizo and Wilcox aquifers located in Anderson County, Texas. Lone Pine WSC has two groundwater wells.

In order to ensure that tap water is safe to drink, the EPA prescribes regulations that limit the amount of certain contaminants in the water provided by public water systems. Food and Drug Administration regulations establish limits for contaminants in bottles water that must provide the same protection for public health. Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that water poses a health risk. Contaminants may be found in drinking water that may cause taste, color, or odor problems. These types of problems are not necessarily causes for health concerns. For more information on taste, odor, or color of drinking water, please contact the system's business office.

You may be more vulnerable that the general population to certain microbial contaminants, such as Cryptosporidium, in drinking water. Infants, some elderly, or immunocompromised persons such as persons with cancer; undergoing chemotherapy; persons who have undergone organ transplants; those who are undergoing treatment with steroids; people with HIV/AIDS or other immune system disorders, can be particularly at risk from infections. You should seek advice about drinking water from your physician or health care providers. If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. We cannot control the variety of materials used in plumbing components. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking. If you are concerned about lead in your water, you may wish to have your water tested. The sources of drinking water (both tap water and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land or through the ground, it dissolves naturally-occurring minerals and, in some cases, radioactive material, and can pick-up substances resulting from the presence of animals or human activity.

Contaminants that may be present in source water include -

**Microbial contaminants**, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations, and wildlife.

**Inorganic contaminants**, such as salts and metals, which can be naturally-occurring or result from urban storm water runoff, industrial or domestic wastewater discharges, oil and gas production, mining or farming.

Pesticides and herbicides, which may come from a variety of sources such as agriculture, urban storm water runoff, and residential uses.

**Organic chemical contaminants**, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can also come from gas stations, urban storm water run-off, and septic systems.

Radioactive Contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

#### **Source Water Assessment Protection**

The TCEQ completed an assessment of your source water and results indicate that some of your sources are susceptible to certain contaminants. The sampling requirements for your water system are based on this susceptibility and previous sample data. Any detections of these contaminants may be found in this Consumer Confidence Report. #### **Information on Detected Contaminants**

The data presented in this report is from the most recent testing done in accordance with the regulations.

#### **Definitions**

The following tables contain scientific terms and measures, some of which may require explanation.

Avg: Regulatory compliance with some MCL's are on running annual average of monthly samples.

Treatment technique (TT): A required process intended to reduce the level of a contaminant in drinking water.

**Action level (AL)**: The concentration of a contaminant which, if exceeded, triggers treatment or other requirements that a water system must follow.

**Maximum Contaminant Level Goal or MCLG:** The level of a contaminant in drinking water below which below which there is no known or expected risk to health. MCLG's allow for a margin of safety.

**Maximum Contaminant Level or MCL:** The highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

**Maximum residual disinfectant level goal or MRDLG:** The level of a drinking water disinfectant below which there is no know or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

**Maximum residual disinfectant level or MRDL:** The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

**MFL:** million fibers per liter (a measure of asbestos)

mrem/year: millirems per year (a measure of radiation absorbed by the body)

**NTU:** nephelometric turbidity units (a measure of turbidity)

pCi/L: picocuries per liter (a measure of radioactivity)

Avg: Regulatory compliance with some MCLs are based on running annual average of monthly samples.

**ppm:** milligrams per liter or parts per million (mg/L) – or one ounce in 7,350 gallons of water.

**ppb:** micrograms per liter or parts per billion – or one ounce in 7,350,000 gallons of water.

**ppt:** parts per trillion, or nanograms per litter (ng/L)

**ppq:** parts per quadrillion, or pictograms per litter (pg/L)
